

TREASURER'S REPORT 2021/2022

Hello everyone and welcome to this year's annual Treasurer's report.

I thank you all for this opportunity to present this report as it is a decade since I last held this role with the Society. Much has changed in this time in the way that financial transactions are handled and reported. The main ones being Internet Banking, the dispensing with cheque books, manual bank deposits and on-line reconciliation of accounts.

A draft (un-audited) copy of the financial statement for the Society has been prepared. The following are notes relating to this statement:

Membership Functions.

Membership – A net surplus of \$29 between budgeted and actual is a very close result given the challenges presented by the years lockdowns and constraints. – a credit to our Membership Secretary, promotions and all members for their contribution in promoting the breed. . Dispatch - shows expenditure down on budget by some 24%. This is largely due to a reduction in printing costs and postage.

Cattle Functions.

Herd Registration Fees are up on last year by approx. 23%, and Transfer Fees are up by over 31%, well exceeding the budgeted total figure by 26.6%. Postage and stationery expenses are up by \$516. Promotions, Showing and Judging – shows a revenue increase of \$492 for Merchandise (Paddles). However expenditure showed an increase of 279% due mainly to the purchase of signs and paddles.

Administration.

Treasury income has been reduced due to the reduction in interest rates. Fixed Term Interest Rates being paid for our three Fixed Term Investments have dropped to between 1% and 2.5%. I expect that this may improve from the flow on as general interest rates rise.

Audit costs for the previous year accounted for some \$1,150 extra expense.

Council - expenses have been close to budget while AGM expenses were increased above budget by venue/dinner costs in Northland.

Summary.

A net deficit of \$715 was recorded for the financial year against a budgeted surplus of \$2,100. This was largely due to the investments made in Publicity (signs) and the extra unexpected audit costs.

The proposed budgeted outcome for the next financial year shows a small surplus of \$260. This allows a continued investment in publicity of \$2000.

Colin then presented the accounts to the meeting and talked about a couple of discrepancies which he will discuss further with the auditor.

He received all documents from Luan Kloppers the past Treasurer in May leaving little time to get things sorted before the AGM Colin will forward all other information in due course. However the figures are correct as on the website and AGM booklet

THAT the Financial report for the 2021/2022 as published on the DCSNZ website be accepted. Moved by Wayne Pettersson/John Walst.....carried unanimously

2022/2023 BUDGET: Colin Read

THAT the budget for 2022/2023 period as published in the AGM booklet be accepted Moved by Liz Thompson/Maureen Pettersson.....carried unanimously

Under current law our society is not required to be audited due to ow revenue. However we are required to be reviewed annually.

Paul Woolaston has offered to review the accounts free of charge but it was agreed that a voucher should be given to him **THAT** the new auditor Paul Woolaston be appointed to review the accounts for the 2022/23 period. Moved by Rosalie Bakker/Colin Read......carried unanimously

Colin also talked about the societies office new auditing requirements and provided the document to the secretary

NEW COUNCIL:

There was no election for President or Council. There were no other candidates for the position of President or council

THAT Wayne Pettersson be accepted as President for 2022/2023 period. Grant Keymer/Liz Thompsoncarried unanimously

Robyn Snelgar is due for re-election this year. No election is necessary

THAT Robyn Snelgar be accepted to council for 2022/2023 period. Bobbie Wisneski/Colin Readcarried unanimously

ANNUAL FEES Membership Fees *THAT* all Membership fees remain the same for the 2022/2023 period. Proposed by council Seconded by Michelle Goodwin carried unanimously

Registrations

THAT registration fees be altered as follows:-Heifer/cows under 24 months if fitted with the DCSNZ Brass Identification tag \$12 Heifer/cow under 24 months if fitted with the DCSNZ Plastic Visual Identification tag \$5

Rationale

The existing fee is \$10.

The existing stock of prenumbered Brass tags is virtually depleted but we hold a number of blank tags that can be manually stamped to carry us over for a while. All costs of tags and stamping are carried fully by the society including postage that has significantly increased over the past few years. Some of these costs need to be carried by members still using these tags. A minimal increase of \$2 is proposed.

Discussion -

John Walst said this will not stop members putting the plastic tags in an envelope. He also talked about the durability of plastic tags and how they are applied.

Wayne responded to John and explained the reasoning for the price increase for brass tags in the hope they will be inserted. There are ongoing issues with cattle being sold without brass tags.

Several members talked about experiences with tagging cattle with brass tags and visual tags & NAIT tags.

Proposed by Council

2022 Remits

Amendment to Constitution Rule 4.4 to Include the Use of Changing Technology Requirements Due to Covid and Travel Restrictions for Members

THAT Constitution Rule 4.4 have the following additions made -

4.4 The quorum for a General Meeting will be fifteen (15) voting members -

- (a) being assembled together at the time, date and place appointed for the meeting, or
- (b) participating in the meeting by means of audio link, audio-visual link, or other electronic communication; or
- (c) by a combination of both methods described in paragraphs (a) and (b)

Rationale: To ensure the Constitution is up to date due and able to cater to the members needs due to the current Covid situation and evolving technology.

Council Annual Reports

President's Report (acting)

Grant Keymer

Looking back at the booklet from last year's AGM, and reading my predecessor's report, brings home how much we have to be thankful for. Covid has faded into the background and lost relevance for most of us; MBovis has been all but eradicated from our shores; and some sense of normality has largely returned, apart from the weather! A&P shows around the country are slowly resuming cattle show rings after a multi-year hiatus, and this offers the prospect of increased exposure for our beloved Dexters.

Recently, Neville Trevarton resigned from the role of Promotions Officer, commenting that he had taken on too many commitments to do justice to them all. Neville, we thank you for being the driving force behind the very successful DCSNZ Signs, which are now gracing various properties and vehicles around the country. Upon receiving the news of Neville's resignation, Wayne Pettersson has volunteered to take over the role, as health and time permits. Wayne, we are delighted to welcome you back, in a less onerous capacity than before.

Now it's time for me to emphasise that the work of running our society is a team effort, provided at minimal cost to members by a dedicated band of volunteers. Our secretary Robyn Snelgar has unrivalled knowledge of the processes we need to follow, in order to keep our society on track and in compliance with the requirements of our Constitution and Regulations. Robyn's experience in the role she has held for so long is the reason our meetings run as smoothly as they do, and her ability to take notes whilst participating fully in Council business is quite extraordinary.

Jillian Walst brings new members onboard in a speedy and efficient manner, recording all their details in the membership file, which is a crucial part of our online system. Enrolment of stud names, preparing the mailing list for each issue of the Dispatch and making sure membership fees are paid as they fall due; each of these are vital tasks Jillian performs throughout the year, in a methodical way with commendable accuracy.

Colin Read is once again in the Treasurer's job which he held many years earlier, and his experience shows. For each Council meeting, Colin prepares an up-to-date financial report which lets us know exactly where we stand. He also deals with our auditor and our bank, and being a former treasurer, I can attest to how much patience that requires.

Bobbie Wisneski helps me with the website and is set to play a leading role in this year's Website Workshop, following the AGM. Rosalie Bakker has made determined efforts to support our members who are involved in showing. With the resumption of cattle classes at various A&P Shows, Rosalie will have more work to do next year. A new initiative is a virtual show, held for the first time this year. We look forward to seeing some of the DCSNZ trophies sent out, after many years sitting on the shelf.

Maureen Pettersson continues to produce our excellent Dispatch magazine, four times each year. In spite of trying personal circumstances over the past year, Maureen has stuck to her guns and continued to hunt out interesting stories, presenting them in an attractive format.

My report would not be complete without mention of our highly-qualified Research Officer Tony Cutten who provided invaluable guidance and analysis during last year's PHA scare. And to our Complaints Officers Tracey Dovey-Reid and Julie Rush, who thankfully didn't have to do anything during the year. Julie has recently stepped down from her role after several years and we record our thanks for being there when she was needed. Julie will be replaced by Deb Goodwin following the AGM.

Last, but certainly not least, we have Michelle Goodwin who is our Herd Registrar. Without Michelle's tireless work, the pedigrees of our animals would become meaningless because they would be filled with errors. The accuracy of the data is paramount to an animal's traceability and its genetic line. Thank you to all members who recognize this and make the effort to send in accurate and complete registration forms. It makes the job easier and quicker.

If Michelle asks you to clarify or correct something sent in on a Registration or Transfer form, please reply politely and patiently, as she is just doing her job in making sure that our Regulations are followed - it's nothing personal. Her role is pivotal to maintaining the accuracy of our Herd Registry, so please be kind next time you communicate with her.



Treasury

Colin Read.

Hello everyone and welcome to this year's annual Treasurer's report.

The last twelve months have seen challenges to the Society through the on-going fallout of COVID on the economy and weather related issues which I'm sure have affected many members.

October's announcement that Wayne Pettersson, due to health reasons was forced to step down from his role as President, came as a shock to all of us. Grant has stepped into the role in an acting capacity and continues with great support from all of us in the meantime.

A draft (un-audited) copy of the financial statement for the Society has been prepared. The following are notes relating to this statement:

Membership Functions.

Membership – A net surplus of \$4,626, down slightly on last year at \$4,828 but is a very close result given the challenges presented by last year's lockdowns and economic constraints. – a credit to our Membership Secretary, Promotions and all members for their contribution in promoting the breed. Dispatch - shows an expenditure increase over the previous financial year by \$473.45. This is largely due to a one-off increase in printing costs and postage when a different supplier had to be used.

Cattle Functions.

Herd Registration and Transfer Fees are up by some \$700 against last year but net revenue for Cattle Functions is down largely because of the introduced new cost of PHA testing (\$1,677). Promotions, Showing and Judging – shows a reduction in expenditure of \$3,421, largely due to the previous year's one-off outlay of \$3215 for signs.

Administration.

Treasury income has increased due to the increase in interest rates being paid on our Term Deposits. Fixed Term Interest Rates being paid for our three Fixed Term Investments have increased to between 2.5% and 5.5%. I expect that this may improve from the flow on as general interest rates rise.

Summary.

A net surplus of \$4750 was recorded for the financial year against a previous years deficit of \$715. This was largely due to the reductions in investments made in Publicity (signs) and reduced audit costs.



Herd Registrar Report

Michelle Goodwin

This year DCSNZ has seen an increase in the number of registered animals which is great news. Personally, I could not provide everyone who enquired, with the animals that they were after. We ended up with a wait-list of people wanting steers and heifers and we sold five bulls which came as a nice surprise. I helped others sell their animals to people I couldn't help. So it was a busy old 8 months.

There were 132 registrations to the YE 2022 made up of 15 bulls and 117 heifers/cows.

Registrations - 2019 - 121 Registrations - 2020 - 105 Registrations - 2021 - 107 Registrations - 2022 - 131 * 15 bulls and 117 heifers/cows Registrations - 2023 so far - 54 * 10 bulls and 44 heifers/cows

There are still ongoing issues with incomplete registration forms being sent in. 50-60% of registrations have to be sent back because they are not compliant or information is missing. Compliance with the DCSNZ regulations are the responsibility of every member.

NAIT tag vs. Visual Tag.

In the registration form there is a field for NAIT Tag and one for Visual Tag. The NAIT tag field is described below. The Visual Tag is either Brass Tag if you want a Brass Tag or your DCSNZ Visual Stud Tag that complies with the following specifications in http://www.dexter-cattle.co.nz/filedownload/downloadfile/fileid/206/filenum/0/src/@random5efaddd3953a0 which is under the Q&A tab on the DCSNZ website.

The NAIT tag field is for the tag number, not the farm number, that is visible when looking in the animal's ear and not the RF Id copied from the NAIT system.

It seems that these numbers are being displayed/formatted differently across the members. We have examples as follows: 818921 – 22 – 1, 818921 – 1, 982-123721198344-GTHR, 982-000359216419-4062199, CDNR-21-263. These are tag numbers that are on display on the face of the tag. Not RF Ids which are displayed like this 982 124528562368.

So please, when you send in NAIT information make sure you are sending in the correct information as it is meant to help identify the animal in the event the Brass Tag or Visual Tag falls out.

Also I know there are frustrations around member's being asked to provide the correct information and it is equally frustrating for me. It is not good practice to make assumptions when this data is vital to the animal's traceability and given there is a variation across members it is up to you to make sure it is right.

Please make sure the service certificate correlates to the animal. I get service certificates that are two or more years prior to the animal being born where people are just not checking the information that they sending in.

Every incorrect field or document delays the processing of the registration.

For bulls you need;

Parentage verification test from InfoGene (PHA test – to be discussed at AGM) Chondro testing is optional. If you have animals that have been chondro tested then I am happy to add this the animals HR record if you would like.

Bull service certificate if you borrowed/leased a bull to sire this progeny or AI certificate.

Send in your registration form with the correct documentation attached and the InfoGene DNA testing number.

Pay for your registration. Bulls under 24 months \$30 and bulls over 24 months \$60. Bulls over 36 months are not registerable.

For cows and heifers


Bull service certificate if you borrowed/leased a bull to sire this progeny or AI certificate.

Send in your registration form with the correct documentation attached.

Pay for your registration. Under 24 months the cost of registration with a visual tag is \$5, or \$12 with a brass tag. For animals between 24 and 36 months the cost is \$10 with a visual tag or \$24 with a brass tag. Animals over 36 months are not registerable.

Grant and I will be looking in to the replacement of the DCSNZ Herd Register so we are keen to hear from members what they would like from a new one.

Personally I would love a system with workflow so you know when things have been received and processed and if there are problems I can send them back to you for correction. Email seems to be very hit and miss and requires me to constantly follow up with people for information. It is time consuming and very frustrating for all.

Resignations have numbered **16** which is a drop from the previous year.



And The New Zealand Agricultural Virtual Show


For the first season post-Covid, this has been a good effort as there has been a significant drop in competitors. We hope there will be more back again competing next year.

These are being collated and send to the Judge for judging. Results will be given at the AGM.

As I am writing this, we are getting ready to go down to Dannevirke where my son is competing at this years Hoof and Hook competition. He made his start with showing Dexters and the first steer he prepared and took to this competition was his ex calf club Dexter steer in 2014. (see the photo below). 

THAT Regulation 8.6a be changed from:

"Males must be sired by a recognised Dexter bull and either out of a recognised pure-bred dam or a Grade 4 dam registered with DCSNZ."

To:

"Males must be sired by a registered Dexter bull and out of a pure-bred dam registered with DCSNZ. Males must have PHA Negative Status, either by inheritance from both parents, or by testing of the animal concerned." **RATIONALE:**

If we don't have an ongoing policy regarding PHA testing for bulls, there is a possibility that in future, a PHA Positive bull could be registered as the offspring of a carrier cow, thus undoing all the work just completed with our bull screening program. Reference to Grade 4 Dam removed as DCSNZ Regulation 7.5 equates G4 with Purebred. 'Recognised' replaced with 'Registered' for clarity.
